

## **MAQUOKETA VALLEY RURAL ELECTRIC COOPERATIVE**

### **2022 ANNUAL MEETING OF MEMBERS**

The Annual Meeting of the Members of Maquoketa Valley Rural Electric Cooperative was held at the Berndes Center in Monticello, Iowa at 12:30 P.M. on the 18<sup>th</sup> day of August, 2022.

The meeting was opened with the playing of the National Anthem and a slide show by Touchstone Energy.

President Thielen, having confirmed a quorum was present, called the meeting to order and offered welcoming remarks. He introduced the current members of the Board of Directors, the CEO, employees, and special guests in attendance.

President Thielen then appointed attorney Phil Brooks as Parliamentarian for the meeting. Secretary Gene Manternach took the official minutes.

President Thielen indicated a roll call of the members was in order unless waived. A motion was duly made, seconded and carried, to waive the reading of the roll of the membership. The members listed in Attachment A had been previously checked against the records of the Cooperative and were present.

The official notice of the meeting was mailed to all members of record on August 1, 2022. A motion was duly made, seconded and carried, to waive the reading of the notice of the meeting.

President Thielen reviewed how members were able to participate in the 2022 Annual Meeting. They could vote in person at the Annual Meeting or they could vote via mail-in ballot, but not both. For mail-in ballots to be counted they were required to be returned to the Cooperative's Anamosa office prior to 12:00 on August 16<sup>th</sup>. The counting of mail-in ballots was completed by three members who were appointed as tellers by Secretary Manternach and overseen by Attorney Brooks.

The minutes of the 2021 Annual Meeting were published in the Annual Report given to each attending member as they registered. A motion was duly made, seconded and carried, to waive the reading of the minutes of the Annual Meeting of the Members held August 19, 2021.

President Thielen then asked if there were any corrections or additions to the minutes. Seeing none, a motion was duly made, seconded and carried, to approve the minutes as written. The President then ordered the minutes to be filed in the records of the Cooperative.

President Thielen turned the meeting over to Treasurer Judy Gotto for the Treasurer's report. She reviewed the financial information that was provided to the members in the Annual Report.

Treasurer Gotto then offered to meet with anyone having questions regarding the financial affairs of the Cooperative.

President Thielen then asked for approval of the Treasurer's report. A motion was duly made, seconded and carried to approve the Treasurer's report and the President then ordered the report to be filed in the records of the Cooperative.

President Thielen stated that the next order of business was the election of three (3) directors for a term of three (3) years each.

President Thielen reviewed the responsibilities of the Board and the nominating process that was followed. All members were notified through the Watts Current newsletter and the Cooperative's social media platforms of the upcoming election and the process for seeking a position on the Board.

President Thielen stated that in accordance with the Cooperative's Articles of Incorporation and Bylaws, the Board of Directors had appointed an independent Nominating Committee consisting of the following three members of the Cooperative:

Mr. Allen Monaghan from Delaware County, chairman  
Mr. Shawn Staner from Dubuque County, and  
Mr. John Stender from Jackson County

The Report of the Nominating Committee was presented, nominating the following members for Directors.

- Tom Stewart for Region 2, including Jackson and Clinton Counties
- Ron Thielen and Mary Goebel for Region 3, Dubuque County
- Billie Zumbach for Region 4 including Delaware, Buchanan and Clayton Counties

No petitions were received from members asking to be included on the ballot.

President Thielen indicated that since there was a contested election for Region 3, each candidate would be given 3 minutes to address the membership. Their resumes were also posted in various locations throughout the meeting room.

Mary Goebel spoke first, followed by Ron Thielen.

President Thielen then asked the membership to complete the ballot they received upon registering for the meeting. The ballots were collected by staff and presented to tellers

appointed by Secretary Manternach for tabulation. Secretary Manternach, Attorney Brooks, and the three appointed tellers left the meeting to count the ballots. The results were combined with the mail in ballots that were returned to the Cooperative prior to the 12:00 August 16<sup>th</sup> deadline.

President Thielen then asked CEO Jeremy Richert to give the CEO's report while the ballots were being counted. Richert reported on the impact a potential generation shortage could have on the MISO region as well as the importance of an "All of the Above" approach to energy generation that would rely on all available sources of generation in efforts to maintain the reliability of the grid at an affordable rate. He then discussed the supply chain issues that the utility industry has dealt with over the last 12 months. Transformers required to connect new services used to be delivered in 12 weeks, current lead times are approaching 2 years. Conductor and underground cable is typically delivered within 10 weeks of order, current delivery time is 50 weeks. On the fiber side, networking equipment needed to connect services to the internet have a 52 week lead time. Pricing has also increased substantially. Material providers have seen a 23% increase across the board over the last 18 months.

Richert then transitioned to review service reliability and rates with the membership. He reported that the Cooperative invested \$2.8 million dollars upgrading line facilities in aging and growing areas of the system in 2021. In 2021, MVEC members averaged 0.7 outages for the year with a total outage time of 56 minutes. The number of outages experienced was 39% lower than the average rural resident in Iowa and the total outage time was 58% lower for the year. For the year's 2017-2021 the outage time experienced by Maquoketa Valley members was 48% lower than the Iowa residential rural average. Richert also reported that the average annual residential kwh cost for 2021 was half a percent lower than what the average kwh cost was ten years prior in 2012.

CEO Richert also provided an update on the Smart Grid Project and MVlink. Richert reported that construction of the initial fiber buildout was nearing completion with 2,259 miles constructed. Total signups for internet and telephone services were at 6,094. MVlink provided internet services to the Major League Baseball game between the Cincinnati Reds and Chicago Cubs at the Field of Dreams movie site. He reviewed an MVlink survey that was completed by the membership that showed that 97% of MVlink users would recommend MVlink to others and 95% of MVlink users reported MVlink meets or exceeds their expectations.

Upon completion of the CEO Report, President Thielen indicated the tellers had completed their count of the ballots for directors and the following individuals were elected to three-year terms:

- Tom Stewart for Region 2
- Ron Thielen for Region 3
- Billie Zumbach for Region 4

President Thielen reminded the membership that any request for a recount would need to be made before the meeting was adjourned.

President Thielen called for any unfinished business to be brought before the meeting. No unfinished business was raised.

President Thielen asked if there was any new business the members wanted to address. No new business was presented.

Having concluded all the necessary business to come before the membership, a motion was duly made, seconded and approved to adjourn the meeting.

The Board of Directors left the meeting to conduct a reorganizational meeting in accordance with the Cooperative's Articles and By Laws.

Attendance prizes were awarded by lot following adjournment.
