

## **MAQUOKETA VALLEY RURAL ELECTRIC COOPERATIVE**

### **2023 ANNUAL MEETING OF MEMBERS**

The Annual Meeting of the Members of Maquoketa Valley Rural Electric Cooperative was held at the Berndes Center in Monticello, Iowa at 12:30 P.M. on the 17<sup>th</sup> day of August, 2023.

The meeting was opened with the playing of the National Anthem and a slide show by Touchstone Energy.

President Thielen, having confirmed a quorum was present, called the meeting to order and offered welcoming remarks. He introduced the current members of the Board of Directors, the CEO, employees, and special guests in attendance.

President Thielen then appointed attorney Tom DeBoom as Parliamentarian for the meeting. Secretary Gene Manternach took the official minutes.

President Thielen indicated a roll call of the members was in order unless waived. A motion was duly made, seconded and carried, to waive the reading of the roll of the membership. The members listed in Attachment A had been previously checked against the records of the Cooperative and were present.

The official notice of the meeting was mailed to all members of record on August 1, 2023. A motion was duly made, seconded and carried, to waive the reading of the notice of the meeting.

President Thielen reviewed how members were able to participate in the 2023 Annual Meeting. They could vote in person at the Annual Meeting or they could vote via mail-in ballot, but not both. For mail-in ballots to be counted they were required to be returned to the Cooperative's Anamosa office prior to 12:00 on August 15<sup>th</sup>. The counting of mail-in ballots was completed by three members who were appointed as tellers by Secretary Manternach and overseen by Attorney DeBoom.

The minutes of the 2022 Annual Meeting were published in the Annual Report given to each attending member as they registered. A motion was duly made, seconded and carried, to waive the reading of the minutes of the Annual Meeting of the Members held August 18, 2022.

President Thielen then asked if there were any corrections or additions to the minutes. Seeing none, a motion was duly made, seconded and carried, to approve the minutes as written. The President then ordered the minutes to be filed in the records of the Cooperative.

President Thielen turned the meeting over to Treasurer Judy Gotto for the Treasurer's report. She reviewed the financial information that was provided to the members in the Annual Report.

Treasurer Gotto then offered to meet with anyone having questions regarding the financial affairs of the Cooperative.

President Thielen then asked for approval of the Treasurer's report. A motion was duly made, seconded and carried to approve the Treasurer's report and the President then ordered the report to be filed in the records of the Cooperative.

President Thielen stated that the next order of business was the election of three (3) directors for a term of three (3) years each.

President Thielen reviewed the responsibilities of the Board and the nominating process that was followed. All members were notified through the Watts Current newsletter and the Cooperative's social media platforms of the upcoming election and the process for seeking a position on the Board.

President Thielen stated that in accordance with the Cooperative's Articles of Incorporation and Bylaws, the Board of Directors had appointed an independent Nominating Committee consisting of the following three members of the Cooperative:

Mr. Shawn Staner from Dubuque County, Chariman  
Mr. John Stender from Jackson County  
Mr. Dave Aschbrenner from Jones County

The Report of the Nominating Committee was presented, nominating the following members for Directors.

- Gene Manternach and Lee Hein for Region 1 - Jones, Cedar, and Linn Counties
- Charlie Peters and Bruce Fisher for Region 2 - Jackson and Clinton Counties
- Judy Gotto for the At Large position – Dubuque County

No petitions were received from members asking to be included on the ballot.

President Thielen indicated that since there was a contested election for Regions 1 and 2, each candidate would be given 3 minutes to address the membership. Their resumes were also posted in various locations throughout the meeting room.

Lee Hein spoke first and was follow in order by Gene Manternach, Bruce Fisher, and Charlie Peters.

President Thielen then asked the membership to complete the ballot they received upon registering for the meeting. The ballots were collected by staff and presented to tellers appointed by Secretary Manternach for tabulation. Assistant Secretary McCullough, Attorney DeBoom, and the three appointed tellers left the meeting to count the ballots. The results were combined with the mail in ballots that were returned to the Cooperative prior to the 12:00 August 15<sup>th</sup> deadline.

President Thielen then asked CEO Jeremy Richert to give the CEO's report while the ballots were being counted. Richert reported on three areas that allow the Cooperative to Empower the Lives of its Members. The first area discussed was reliability of the electric and fiber networks. He reported that electric outage durations are 28 minutes less on average than what members experienced 20 years ago. In 2022, MVEC members averaged 0.9 outages for the year with a total outage time of 65 minutes. The total outage time experienced was 45% lower than the average rural resident in Iowa. For the year's 2018-2022 the outage time experienced by Maquoketa Valley members was 49% lower than the Iowa residential rural average. Richert reported that the fiber network also performed very well in 2022 with 0 minutes of entire network outage time where MVlink was not able to provide bandwidth to the membership. Richert also reported that MVlink received an ACSI score of 88 out of 100, which was 20 points and 33% higher than the average score for internet providers.

Richert then proceeded to discuss the importance of the electric and fiber network needing to be robust enough to handle not only the demands of today's members but prepared to handle the growing needs of the membership in the future. He stated that the electric and broadband systems both saw record peak usage during a polar vortex event on December 23, 2022 and that both systems performed without issue. In 2022, the Cooperative invested just under \$11 million dollars upgrading and maintaining line facilities and substations in aging or growing areas of the system. As part of the long range engineering plan the Cooperative reviewed the potential impact of various penetration levels of electric vehicles on the power grid and it was determined the grid is in a good position to handle the potential load increase from electric vehicles in the coming years. Efforts to maintain and expand the fiber network are also ongoing as the Cooperative is working on a project to increase the bandwidth of the fiber transport rings from 10 Gbps to 100 Gbps in preparation for the increased bandwidth needs of the members.

Richert then discussed the potential impact state and federal policies could have on what future power generation looks like and the potential negative impact of regulations that would likely result in the early closure of many stable base load generating facilities over the next 10 to 15 years. These proposed rules could undermine decades of effort to harden the electric grid. He reviewed the efforts of the Cooperative's power provider, CIPCO, to use an All the

Above approach to ensure adequate generation exists to reliably serve the membership in the future.

The next item of discussion was affordability of services. Richert reported that MVEC's rates have increased 3.9% since prior to the pandemic of 2020. This 3.9% increase is significantly lower than the 25% average increase rate payers are seeing across the country over the same time period. Richert reviewed the 3.5% rate increase that was implemented in April of 2023 and discussed why the increase was done via the monthly service charge and not the actual energy rates.

Richert finished his update with a discussion on things the Cooperative does to empower the communities that the membership lives in. Some examples included a food drive to restock the food pantry's across the Cooperative service area with over 420 pounds of food being collected, revolving loan fund dollars to support the growth of businesses and services, as well as employee's volunteering over 1,600 hours of their personal time to support scout groups, athletic teams, and school events.

Upon completion of the CEO Report, President Thielen indicated the tellers had completed their count of the ballots for directors and the following individuals were elected to three-year terms:

- Gene Manternach for Region 1
- Charlie Peters for Region 2
- Judy Gotto for the At Large position

President Thielen reminded the membership that any request for a recount would need to be made before the meeting was adjourned.

President Thielen called for any unfinished business to be brought before the meeting. No unfinished business was raised.

President Thielen asked if there was any new business the members wanted to address. No new business was presented.

Having concluded all the necessary business to come before the membership, a motion was duly made, seconded and approved to adjourn the meeting.

The Board of Directors left the meeting to conduct a reorganizational meeting in accordance with the Cooperative's Articles and By Laws.

Attendance prizes were awarded by lot following adjournment.
