Powering Opportunity

On behalf of our Staff and Board of Directors, we are pleased to invite you to this year's Annual Meeting on Thursday, August 15th at the Peosta Community Centre in Peosta, Iowa. In an effort to encourage the highest number of members as possible to participate in the governance of the Cooperative they own, we are once again allowing members to participate by mail or in person. We encourage you to attend this year's annual meeting in person if possible, but if your schedule does not allow, please return the mail-in ballot included with this Annual Report to ensure your voice is heard. Mail-in ballots must be received at our office by noon on August 13th (and in the postage-paid envelope enclosed in this mailing) to be considered valid.

The theme for this year's report is Powering Opportunity. In addition to annual information on cooperative business, this report highlights how MVEC powers opportunity in the areas we serve and beyond.

First and foremost, the success of your Cooperative is based on the hard work and dedicated efforts of our employees and we make it a priority to power opportunities for them with training and education to enrich their careers and strengthen our offering to members.

MVEC first powered opportunity in 1935 when our cooperative formed to bring safe, reliable and affordable electricity to rural eastern Iowa to improve the lives of residents in our service territory. Bringing power to our rural areas was a life changing event and MVEC has continued to invest in technology and system upgrades to ensure our electric grid has been able to support the growth and needs of residents, businesses, and communities within our service territory.

The launch of our MVlink fiber internet project has powered significant opportunity within our service area and allowed us to provide world-class internet speeds in the most remote areas of our service territory. We continue to evaluate options to expand the MVlink footprint as well as upgrade our network capabilities so it is able to support the always-increasing broadband needs of our membership.

In addition to serving members with reliable electricity and internet, we support opportunity in the communities we serve by giving back through donations, employee

volunteer work and economic development efforts. including the Revolving Loan Fund MVEC manages to assist small businesses in our area and ensure that needed services are available where our members live and do business.

Another way that we as a co-op power opportunity for our communities is by supporting volunteer efforts across our service area. One recent example of this is the statewide Shine the Light contest sponsored by Touchstone Energy Cooperatives and Iowa Association of Electric Cooperatives. Shine the Light recognizes volunteers for their hard work and commitment. In 2023, one of MVEC's employees, Megan Ruley, nominated Heather Weers for her work with Sleep in Heavenly Peace-Jones County. Heather was one of three winners from across the state selected to receive \$2,500 for Sleep in Heavenly Peace. In addition to this recognition, MVEC employees held a bed build for the charity to help ensure that no child sleeps on the floor in our community.

Just this June, we powered opportunity as well as a brighter future when one of our linemen, Journeyman Bailey Bautsch, traveled to Guatemala to bring power to a remote village as part of an international program with the National Rural Electric Cooperative Association. NRECA has been organizing international projects since 1962. MVEC was proud to be part of a group of 14 linemen from Iowa and Minnesota to spark opportunity for this region creating opportunities for improved healthcare, education, and economic development.

Participating in an international project like this is not only transformative for the people who receive access to electricity, but also for the linemen who do the work. Electric cooperatives have a proud legacy of serving those who need it most. The Guatemala project connects us to our roots of bringing electricity to rural Iowans 89 years ago. We also believe in the cooperative principle of cooperation among cooperatives, and this project demonstrates how we can work together to power a brighter future for those in need across the world.

MVEC is committed to powering opportunity through our services and our partnership in the communities we serve. We look forward to continuing to meet your electric and fiber internet needs into the future and hope to see you in Peosta on August 15th.

With my experience in business ownership, exceptional customer service, and relationship building I know I can continue to help MVEC succeed in providing affordable and reliable power to their members.


What is your greatest hope for the Cooperative's future?

TREASURER'S REPORT

The Statement of Operations shows operating revenues increased by \$1.2 million from 2022 to 2023 for a total of \$42.2 million; \$36.3 million was recognized from the sale of electricity and related charges and \$5.9 million from the sale of internet and telephone services. The report also shows a total net margin of \$3.9 million for 2023, which was allocated to patronage dividends, and reserve for losses and surplus in accordance with Iowa law.

The Cooperative added \$11.7 million in total utility plant as we continued investing in our smart grid build-out and improving our electric grid. This necessitated borrowing \$9,000,000 to fund capital projects.

In October 2023, \$800,000 in patronage dividends were paid to current and past members, retiring \$429,000 of the 2008 dividends and \$370,000 of the 2012 dividends. Earlier this year the Board of Directors allocated \$1.4 million of the 2023 net margins to the membership for reimbursement in the coming years.

Eide Bailly, an independent audit firm from Sioux Falls, South Dakota, performed an audit of the Cooperative's financials. Their opinion as noted in this annual report states the financials conform to generally accepted accounting principles and no issues of concern were identified.

Cooperatives, including MVEC, were founded with the mission of improving the lives of those we serve. At the core of this mission is providing safe, reliable and affordable electricity to our members. Over the last 89 years, we have invested in technology to improve our system's reliability and efficiency to continue to deliver on that mission.

MVEC's reliable electricity powers opportunity for our business and residential members by allowing them to work effectively and live more comfortably. Each year, MVEC not only invests in routine maintenance of the cooperative's power plant but MVEC's management team and Directors prepare for future growth by developing a plan and working diligently to improve our grid's capability to support members' growing needs.





MVEC purchases its power from Central Iowa Power Cooperative (CIPCO). CIPCO works to maintain a diverse portfolio of energy sources to strike a balance between reliability, affordability and sustainability. MVEC and Iowa's locally owned and governed electric cooperatives continue to support an "all-of-the-above" power generation strategy that ensures reliable and affordable electricity for our members. Iowa electric cooperatives are important advocates for a balanced approach in addressing energy issues as we work to power lives and empower the communities we serve.

POWERING OPPORTUNITY

with High-Speed Fiber Internet



Similar to the vision of MVEC's founding members back in 1935, the cooperative once again stepped up to create opportunity for rural Iowa with the investment in our smart grid fiber network. MVEC launched MVlink in 2016 to bring fiber internet to the most rural areas of our service territory, allowing members to work, learn and entertain with reliability and speeds they had not experienced before.

In 2023, MVEC completed its annual MVlink Fiber Internet member-wide customer satisfaction survey. The responses were sent to the American Customer Satisfaction Index (ACSI®), a company that measures customer satisfaction across multiple industries throughout the entire US. MVlink received an ACSI score of "88" out of a maximum score of "100" which was 13 points higher than the average Fiber Internet Service Provider score of 75, as well as 20 points higher than the average Internet Service Provider score of 68, per the industry ratings in the 2023 ACSI Internet Service Provider Report.

Over the last few years, MVEC has established a fiber line crew to maintain the Fiber plant and accommodate the growth of MVEC's fiber footprint. Having a full-time fiber line crew gives MVlink more control over maintenance and project timelines.

This year, with the support of federal grant funding (NOFA 8 Empower Rural Broadband Grant Program), MVEC expanded the co-op's fiber network to serve rural areas of Delaware and Dubuque Counties. MVlink has also expanded into the communities of Ryan, Dundee and Earlville because they were not covered by a quality fiber connection. MVEC now has more than 7,000 MVlink fiber internet members and counting.

MVEC's investment in smart grid technology levels the playing field for rural Iowa, providing fast, reliable local internet to propel members' businesses, education and lives forward.

Maquoketa Valley Electric Cooperative is committed to improving the quality of life for our members and the communities we serve as well as the world we live in. The sixth Cooperative Principle, Concern for Community includes those communities nearby and sometimes, those thousands of miles away. Just this past June, one of MVEC's linemen, Journeyman Bailey Bautsch, traveled to Guatemala to bring power to the rural village of Las Peñas, powering opportunity for that remote village much like coop founding members did in the US in the 1930s. The linemen were in Guatemala for just over two weeks and during that time, they built 3.5 miles of electric infrastructure and wired more than 30 homes for lights and outlets.

Cooperatives are built on the foundation of cooperation and this past spring, MVEC and several other co-ops demonstrated the power of being part of the co-op community. Six MVEC linemen traveled to Arkansas in May to provide mutual aid to Carroll County Electric to help them restore power to the area that was devastated by a tornado.

Closer to home, MVEC supports many non-profit organizations, schools, community and youth organizations. Each year, we help send students from area FFA Chapters to Washington Leadership Conference to provide them with the opportunity to experience our nation's capital and develop leadership skills that they bring back to their communities.

MINUTES OF 2023

Abbreviated Version of Minutes of the 2023 Annual Meeting of Members (Full version of the minutes is available at mvec.coop/annual-meeting)

The Annual Meeting of the Members of Maquoketa Valley Rural Electric Cooperative was held at the Berndes Center in Monticello, Iowa at 12:30 pm on the 17th day of August, 2023. President Thielen, having confirmed a quorum was present, called the meeting to order and appointed attorney Tom DeBoom as Parliamentarian for the meeting. Secretary Gene Manternach took the official minutes. Members waived the reading of the roll and the reading of the official notice of the meeting, which was mailed along with a voter response card, to all members of record on August 1, 2023. The minutes of the Annual Meeting of the Members held on August 18, 2022, and the Treasurer's Report given by Treasurer Judy Gotto, were approved. President Thielen stated that in accordance with the Cooperative's Articles of Incorporation and Bylaws all members were notified of the process for seeking a position on the Board of Directors and an independent nominating committee was appointed.

The Nominating Committee presented the following members for Director positions: Gene Manternach and Lee Hein for Region 1; Charlie Peters and Bruce Fisher for Region 2 and Judy Gotto for the At Large position (Dubuque County). President Thielen indicated that since there was a contested election for Regions 1 and 2, each candidate would be given 3 minutes to address the membership. Their resumes were also posted in various locations throughout the meeting room. Lee Hein spoke first and was followed

in order by Gene Manternach, Bruce Fisher and Charlie Peters. President Thielen then asked the membership to complete the ballot they received upon registering for the meeting. The ballots were collected by staff and presented to tellers appointed by Secretary Manternach for tabulation. Secretary Manternach, Assistant Secretary McCullough, Attorney DeBoom, and the three appointed tellers left the meeting to count the ballots. The results were combined with the mail in ballots that were returned to the Cooperative prior to the noon August 15th deadline.

The membership elected the following members to Director positions for three-year terms: Gene Manternach - Region 1, Charlie Peters - Region 2, and Judy Gotto – At Large. No unfinished or new business was raised by the members present. With all necessary business concluded, the meeting was adjourned.
